## **OLD BUSINESS**

- **One uniform patron registration form Committee Report** –Chris Corter (CCLD)reported that she and Karen Deutsch (Wayland) have started working on sorting out commonalities amongst the registration forms submitted from member libraries. There was discussion. The committee was to meet directly after the DAC meeting, but Marsha Watson (Hammondsport) was excused from the DAC meeting due to illness, thus the meeting would have to be rescheduled.

-Resolution wording detailing how member libraries can negotiate payment for lost items with each other libraries Committee Report – Chris Corter and Brian Hildreth (STLS) presented a draft recommendation. There was discussion and some additions. DAC representatives will get input from their charted population groups.

-**STLS Makerspace Committee update-** There has been no formal committee formation, but Pauline Emery (Corning) reported that Corning and Elmira staffs have been informally sharing information and Al Oliveras (STLS) and Lorie Brown (STLS) will be demonstrating a 3D printer at the STLS annual meeting on October 6<sup>th</sup>. The new options would go into effect January 1st 2016. After one year, statistics will be assessed to determine how the new loan periods are affecting customer service around the system.

Brian expressed appreciation for all the input he has received from member libraries about the proposed recommended universal circulation periods. He explained his request to add Option 4 (opt out) which will add a control group and provide a constant data set to the statistics collected next year. All STLS libraries can use the statistics to determine if libraries that choose options 1 through 3 had positive results.

Representatives reported that the libraries they represent did not always get back to them. Those that did expressed that the options provided were sufficient and often named the specific ones they would bring back to their Boards for approval.

No motions were made yet because Option 4 has been newly added. DAC representatives will let their constituents know about the change.
